The Victor Valley Station (a.k.a. Apple Valley Station), located at Dale Evans Parkway near I-15, will be the premier station in the High Desert for Brightline West, which will be the first true high-speed passenger rail system in the U.S. with speeds up to 200 miles per hour.

The Apple Valley Station will serve a vital role in connecting the High Desert to business and entertainment destinations throughout Southern California, Las Vegas and beyond, and attract economic development in the region.

Apple Valley will also be home to a Maintenance of Way facility that will be located within a 300-acre adjacent area that Brightline West purchased for future development.

REGIONAL CONNECTIVITY

With flagship stations in Las Vegas at the northern terminus and Rancho Cucamonga at the southern terminus at the existing multimodal Cucamonga Station, the High Desert will have two stops – Apple Valley and Hesperia.

From Apple Valley, passengers can take Brightline West to Cucamonga Station where they can transfer seamlessly onto Metrolink's San Bernardino Line or Omnitrans bus services, which connect to major business, shopping and entertainment centers from Redlands to Los Angeles, and daily shuttle service to Ontario International Airport.

LOCAL CONNECTIVITY

The Apple Valley Station will provide local connectivity through Victor Valley Transit, Rideshare, Taxi, and Uber/Lyft services.
